

Ancil Hoffman Park

Ancil Hoffman Park is located on Tarshes Drive.

From U.S. Highway 50, take the Watt Avenue off-ramp. Head north to Fair Oaks Blvd and make a right. Follow Fair Oaks Blvd. to Van Alstine and make another right. Make a left onto California Avenue, then turn right at the park's entrance.

Discovery Park

A 302-acre park, Discovery Park is located beside 1-5 in downtown Sacramento. From 1-5 take the Richards Blvd. off-ramp then go west to get to the South entrance of the park, or follow the Garden Highway exit east from 1-5 to find the North entrance. Signs denote the park's location from 1-5.

C.M. Goethe Park

From U.S. Highway 50, take the Bradshaw Road off-ramp. Turn right at Folsom Boulevard and follow the brown-and-white signs to the park entrance on Rod Beaudry Drive.

Howe Avenue Access

Howe Avenue is easy to access from U.S. Highway 50. Simply take the Howe Ave. off-ramp and head north. Turn right immediately onto La Riviera Drive. Follow the La Riviera off-ramp straight to the park's entrance.

Jedediah Smith Memorial Trail

The Trail can be accessed from most parks in the American River Parkway and from parks in Folsom including:

Paradise Beach Recreation Area

From U.S. 50, take the Howe Ave. off-ramp, heading north. Make a left on Fair Oaks Blvd., then a right on Carlson Drive. You will find Paradise Beach at the intersection of Carlson and Sandburg Drives, over the levee from Glen Hall Park.

Rossmoor Bar

From U.S. Highway 50, take the Sunrise Blvd. off-ramp, heading north. Turn left onto Coloma Road. Turn right on either El Manto or Rossmoor Drive to access the park.

Sacramento Bar

From U.S. Highway 50, take the Sunrise Blvd. off-ramp. Head north to Fair Oaks Blvd. Make a left on Fair Oaks, then an immediate left onto Pennsylvania Avenue. The kiosk is at the end of Pennsylvania Avenue, just past Magnolia Street.

Sailor Bar

From U.S. 50, exit onto Hazel Avenue. Make a left at Winding Way, then another left on Illinois Avenue. The park entrance will be at the bottom of a small hill.

Sarah Court Access

From U.S. Highway 50, take the Sunrise Blvd. exit north. Turn left at Fair Oaks Blvd. Make a left at Boyer Drive, then turn onto Sarah Court. Follow the brown-and-white signs to the parking lot.

Upper Sunrise & Lower Sunrise Recreation Areas

From U.S. Highway 50, exit at the Sunrise Blvd. off-ramp. Head north. Just before the American River overpass, turn right into the park entrance, which is marked by a sign. Past the entry kiosk, turn left to get to Lower Sunrise and right to enter Upper Sunrise. Upper Sunrise may also be accessed from Gold Country Blvd just west of Hazel Avenue (north of Highway 50). The fish hatchery parking lot is accessible only from the Hazel Avenue access to Upper Sunrise.

Waterton and S.A.R.A Accesses

From U.S. Highway 50, take the Watt Ave. North exit. Then make an immediate right onto the La Riviera Way off-ramp. From there, make a right down La Riviera Drive, then a left on Waterton Way. Turn into the parking lot for the access. The S.A.R.A. access is located a few blocks east on Rogue River Drive.

Watt Avenue Access

From U.S. Highway 50, take the Watt Avenue North exit. Stay in the right lane and exit at La Riviera Drive. Make a left at the end of the La Riviera ramp, and then make a right into the park's gates.

William B. Pond Recreation Area/ Arden Bar

From U.S. Highway 50, take the Watt Avenue northbound off-ramp. Turn right at Fair Oaks Blvd., then make another right on Arden Way. Arden Way will come to an end at the park's entrance. To access the western entrance of the park, from the Watt Avenue off-ramp, take American River Drive east and turn right on Harrington Way.
